



# THE SCHOOL GOVERNANCE (CONSTITUTION) (ENGLAND) REGULATIONS 2012 ("THE REGULATIONS")

## INSTRUMENT OF GOVERNMENT: VOLUNTARY CONTROLLED SCHOOL

1. The name of the school is:

#### ST GEORGE'S CHURCH OF ENGLAND PRIMARY SCHOOL

- **2.** The school is a voluntary controlled school.
- **3.** The name of the governing body is:

### THE GOVERNING BODY OF ST GEORGE'S CHURCH OF ENGLAND PRIMARY SCHOOL

- **4.** The governing body shall consist of:
  - (a) 2 Parent governors;
  - (b) 1 LA governor;
  - (c) 2 staff governors;
  - (d) 2 foundation governors;
  - (d) 3 co-opted governors
- 5. Total number of governors 10
- **6.** Term of office for all governors is **4** years
- 7. The name of the foundation body entitled to appoint foundation governors is:

#### THE LICHFIELD DIOCESAN BOARD OF EDUCATION

8. a) The holder of the following office shall be a foundation governor ex-officio: -

### THE PRINCIPAL OFFICIATING MINISTER OF THE PARISH OF ST GEORGE'S

b) The **ARCHDEACON OF SALOP** shall be entitled to appoint a foundation governor to act in the place of the ex officio foundation governor whose governorship derives from the office named in (a) above, in the event that that ex officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 21(1) of the Regulations.

**9.** The name of the person entitled to request the removal of ex-officio foundation governor is: -

### THE ARCHDEACON OF SALOP

**10.** The religious ethos of the school is as follows: -

Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level

The school aims to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith, and promotes Christian values through the experience it offers to all its pupils.
